## Minutes of the Council's Meeting - 7.00 pm, Tuesday 17 January 2023

1. **Apologies:** Gordon Owen, Lowri Owen, William Victor Owen, Einir Thomas and Gareth Thomas.
2. **Declaration of Interest** – County Councillor K. Taylor declared an interest in planning matters because of his position on the Planning Committee.
3. **Minutes of the previous meetings**  
The minutes of 15 November 2022 were accepted as being correct (Proposed Cllr. Celfyn Furlong, seconded Cllr. G.O. Jones.)
4. **Matters arising from the minutes.**
  - 4.1 Playing Field: The work on the boundaries had been delayed because of the weather. It was agreed to ask Rospa to inspect the equipment.
  - 4.2 Defibrillator – Cllr. G.O.Jones was still trying to contact The North Wales NHS charity, Awyr Las for advice on how best to approach the project.
  - 4.3 Dog waste bag dispenser - this was ongoing. It was also agreed to ask for another bin by Ysgol y Tywyn.
  - 4.4 Any other matters arising from the minutes: none
5. **Planning Decisions** – none.
6. **Planning Applications**
  - 6.1 **HHP/2023/5 Isfryn, Caergeiliog**  
Full application for alterations and extensions – no objections.

- 9.7 Vacancies for two Town/Community Council Members on the Isle of Anglesey County Council's Standards Committee – noted that the elected members were Councillor Margaret Ann Thomas Llangefni Town Council and Councillor Iorwerth Roberts Bryngwran Community Council had been elected.
- 9.8 Tywyn Trewan Management plan - no observations
- 9.9 Traffwll Solar Farm – Notice given that the Welsh Ministers have been allowed further time to consider the Inspector's Report on the application. The determination period will now end on 13 March 2023.

### 10. **Member Reports**

- 10.1 Cllr. Sharon Parry expressed concerns about the lack of street lights between the A55 junction and Minffordd Road. It was agreed that the clerk would make enquiries with the County Council to see what options were available. She would also remind them of Cllr. Siân Jones's earlier complaint about the volume of stones that had fallen onto the pavement.
