
Minutes of the Council's Meeting - 7.00 pm, Tuesday 16 November 2021

The Chairman requested that there be minute of silence in memory a former councillor Mr Arthur Roberts, Afallon, Caergeiliog who had passed away recently. Members expressed their sincere condolences to his family.

- **1. Apologies:** Cllrs. Siân Enfys Jones, Einir Thomas and Beryl Salisbury.
- 2. **Declaration of Interest** Cllr. William Victor Owen declared a prejudicial interest and left the meeting and took no part in the discussion on item 7.1 planning application VAR/2021/74.

3. Minutes of the previous meetings

The minutes of 19 October 2021 were accepted as being correct (Proposed Cllr. Celfyn Furlong, seconded Cllr. Gwilym O. Jones.)

- 4. Matters arising from the minutes.
- 4.1 Playing Field:- The work on the safety surfaces was outstanding, Cllr. Gordon Owen would remind the contractor. There was nothing further to report about the installations promised by Kenton Jones Ltd. Cllrs. Celfyn Furlong and Gwilym Jones offered to remove the old benches. The clerk had obtained various prices for recycled benches (average cost £375 £400 +VAT and carriage). It was agreed to purchase the one that represented the best value for money.
- 4.2 Footpaths:- The County Council had carried out a detailed inspection of all footpaths on Anglesey and posted their findings and photographs on their website. There was minimal work required in Llanfair yn Neubwll and this could wait until the spring. The County Council had also been made aware of the complaint received from the landowner regarding footpath 10 (Ysgybor Bach).
- 4.3 Notice Board IOACC had provided a map of the ground that they owned by the church in Llanfihangel yn Nhowyn and had asked the Community Council to confirm the exact location of the proposed notice board. They also wanted a picture of how it the notice board would look. It was agreed that Cllr. Furlong would visit the site to ascertain the best possible location in terms of safety and ease of fixing and that the clerk would provide a photograph of the Caergeiliog Notice Board as the intention was to purchase another of these if permission was received from IOACC.

- 4.4 Parking issues Caergeiliog it was agreed to request a site meeting to discuss the parking problems by the village hall. However, a full and thorough consultation would be required before any decision was taken as it was clear that some local residents had concerns about having double yellow lines in front of their properties.

5. Other Parochial Matters

5.1 Bus Service Llanfihangel yn Nhowyn – Concerns had been raised about the curtailing of the bus service through RAF Valley. Cllr. Gwilym Jones had expressed his concerns to IOACC who confirmed that this bus route was serviced by a commercial bus company who had decided that the service wasn't viable. They would therefore only provide an early morning and early evening service. IOACC promised to see what they could do.
