3. Minutes of the previous meeting

The minutes of 15 July 2025 were accepted as being correct (prop. Cllr. S.E. Jones, sec. Cllr. G.O. Jones).

4. Matters arising from the minutes.

4.1 Playing Field: There were no significant risks identified in the ROSPA report but it was noted that the play house should be modified to improve safety standards.

Craig Redmond would remove the dying ash trees in the coming weeks.

It was noted that barriers preventing children from running straight on to the road from the play area by 31-33 Treifan Estate had been removed. The clerk would ask for these to be returned.

A complaint had been received that footballs were being kicked at the back of the houses from the play area on Treifan Estate. Agreed to consider if there was space for a football net there bearing in mind that the play area lease did not cover all of the grassed area towards parking area by Cae Ifan.

- 4.2 Village Hall: Work had commenced on the heating system. The Community Council was to receive a grant of £1000 from the Bro Llynnoedd Alliance towards the cost of connecting the new water supply.
- 4.3 Street Lights Lôn Minffordd agreed to wait and see how many would be required once the developer of the new estate on Minffordd Road had installed those agreed as part of their planning application.
- 4.4 Cllr. W.V.Owen had cut the grass obscuring the Minffordd Road sign.
