### 3. Minutes of the previous meeting

The minutes of 20 May 2025 were accepted as being correct (prop. Cllr. S. Parry, sec. Cllr. W.V. Owen)

- 4. Matters arising from the minutes.
- 4.1 Playing Field: The equipment was due a full ROSPA inspection this month and further work was required on the benches and hedges.
- Village Hall: R.G. Hire had still not laid the new waterpipe. It was agreed to accept the quotations of £522 plus VAT and £365 plus VAT for the installation of external lights and an electicity supply and sockets to the store room.
- 4.3 Street Lights Lôn Minffordd it had been estimated that 5 lamps would be sufficient to light the road between Dafarn Cwch and the A55 junction agreed to purchase one lamp in the current financial year.
- 4.4 Tywyn Trewan Board of Conservators: Cllr. Einir Thomas had attended a meeting with the Board on 4th June. They were continuing to implement the recommendations of the Tywyn Trewan Management Plan commissioned in 2022. There was no information forthcoming about any current challenges, but it was said that they had insurances in place and that IOACC would be asked to pay their legal bills. Although there were two Llanfair yn Neubwll Commnity Councillors on the Board of Conservators they could not be considered Council Representatives as the Board was reluctant to consult or share information with the Council. The Council had no part in any of their decision making processes.

6.1 Final Accounts 2024/25

The Internal Auditor's had completed his audit of the 2024/25 accounts and confirmed that the accounts were in order. There were no recommendations for the Council's attention, however he had noted that the Council appeared to have a high level of reserves at the end of the financial year. The Council had put aside these reserves to meet the costs of essential work required on the village hall as well as the installation of street lights on Minffordd Road. These expenditures would reduce the Council's reserves considerably. It was unanimously agreed to accept the report, the Chairman and RFO would now certify the Annual Return and send all the requested documents to the External Auditors.
