### 9 Member Reports

9.1	Cllr. Celfyn Furlog Drew attention to the state of the bus shelters, Cllr. Victor Owen said that he had inspected them all, some of the perspex panels had discoloured but there were no repairs needed. Some had graffiti, but nothing offensive, each one needed cleaning. The clerk would arrange this.
9.2	Cllr. Gwilym Jones; Had been contacted by Bryngwran residents opposing the proposal to put underground cables to and from the Bryngwran Solar Farm across private land between the A55 and the Caer Elen to Engedi road. It was noted that most of the land was outside the Llanfair yn Neubwll boundary, however it was agreed that the proposal was a favoured option for Llanfair yn Neubwll residents as it would be far less disruptive than having cables laid under the road.
9.3	Cllr. Sharon Parry Said residents in Llanfihangel yn Nhowyn were still expressing concerns about the number of large (business) vehicles that were parked on the road in the Minffordd Road,
