- 1. Apologies: Siân Enfys Jones, Gordon Owen, Lowri Owen and Dyfed Williams.
- **2. Declaration of Interest** declarations of personal interest: Cllr. K. Taylor planning matters because of his position on the Planning Committee.
- 3. Minutes of the previous meetings

The minutes of 20 June 2023 and 26 June 2023 were accepted as being correct. (Proposed Cllr. G.O Jones, seconded Cllr. W.V. Owen.)

- 4. Matters arising from the minutes.
- 4.1 Playing Field: The two recycled plastic benches were on order. The ROSPA report was to hand, there were no major issues raised although it had been identified that the play house provided by Kenton Jones Ltd. required attention. It was agreed to take action to address the recommendations as soon as possible.
- 4.2 Defibrillator Cllr. Gwilym Jones reported that Scottish Power (SP) would connect an electricity supply direct from the network to a galvanised post that would would have to be erected to hold the defibrillator. There was no indication of cost but he was to establish this and ask whether SP would contribute towards this. It was also noted that County Council approval was required.
- 4.3 Street Lights and pavements Minffordd Road IOACC had advised that they would not support the use of solar street lights on Minffordd Road as they were not deemed suitable for installing along a highway. They would however be able to install street lights one at a time. The power supply would have to come from a point by the from the Dol Eithin / Lon Bach junction cost of installation £8650 +VAT. Need to establish whether there were any grants available before proceeding.
- 4.4 Village Hall: Cllr. Celfyn Furlong and the clerk were due to meet with the Solicitors on 27th July 2023.
- 4.5 Any other matter arising from the minutes:It was agreed to cut footpaths 20 and 27 again as they were severely overgrown.
