- 4.1 Playing Field: Nothing further to report.
- 4.2 Defibrillator A defibrillator had been purchased and delivered to the Church in Llanfihangel yn Nhowyn where it was to be installed by the MOD. The clerk would pursue the relevant consents for installing a similar unit in Caergeiliog.
- 4.3 Street Lights and pavements Minffordd Road it was said that there were BT, water and electricity services in the green space on the lane to Caergeiliog and possibly superficial water pipes only in the verge along Minffordd Road. 'The County Council officers were confident that lights could be placed in the grass verge to save costs. A new estimate will be calculated in early April when new prices had been agreed with the contractor.
- 4.4 Village Hall: the Village Hall Trustees were due to meet with their solicitor on 28 February 2024.
- 4.5 Parc Solar Traffwll the drop in session at the Village Hall on 8.2.2024 was well attended. Residents were keen to understand the construction timeline, the need to divert traffic etc whilst the cable connecting the solar farm with the electrical substation on Cymyran Road was taking place. Members were particularly concerned about the lack of information forthcoming via IOACC, the work was likely to take several months and there were concerns about the access, the damage to the road surface, the changes to the bus service etc.
- 4.6 RAF Valley Runway refurbishment Residents were to be given the chance to learn
