- 4.1 Playing Field: It was agreed to remove the old benches from the play area and to replace them purchase two recycled plastic benches from Earth Anchors Ltd. and to pay for new wood to repair the shed. ROSPA were due to do a survey of the site shortly.
- 4.2 Defibrillator Cllr. Gwilym Jones was due to meet with Scottish Power to discuss the electricity supply by Rhen Ysgol. There was no funding available for this, several thousand pounds would need to be set aside to site it there. A decision would be made when the total cost was known.
- 4.3 Street Lights and pavements Minffordd Road this was on going.
- 4.4 Village Hall: The Hall Management Committee had welcomed the suggestion that Caergeiliog Village Hall be transferred on a lease agreement to the Community Council as it was felt that the hall would most certainly have to close without the support of the Council. The Chairman and the Clerk would seek legal advice on the way forward with this.
