Public Representation

A number of local residents were welcomed to the meeting. It was agreed as this was not a public meeting that they should be given the opportunity to convey their concerns about the refurbishment work that was due to commence at RAF Valley before starting the main meeting. Several residents expressed concerns about the refurbishment works and the lack of consultation. Mr Geoff Jones outlined the health and safety issues as explained in a detailed submission that he had circulated to the RAF, the County Council, Albert Owen MP and the Community Council. Main areas of concern:

- No consultation about a massive civil engineering project that would have a major effect on residents on Cymyran Road;
- The large number of HGV vehicles that would be using the unclassified road (up to 11 per hour between 8am and 5pm)
- Major risks to regular road users including school children, walkers, cyclists, horse riders etc.
- No confirmation that risk assessments had taken place.

The Community Council confirmed that there had been no consultation and that they shared the concerns conveyed. It was agreed that the representatives from the Community Council would make clear these concerns at the meeting that had been arranged by the RAF on Thursday 17th March 2016. Cllr. Gwilym O. Jones and Cllr. Richard Dew would be attending along with The Leader of the Council and various Chief Officers of the County Council. It was also confirmed that the Council Leader and the senior officers concerned had already been made aware of the Community Council's concerns about the lack of consultation.
