- 1. Playing Field: Noted Quote received from McVenture Play Co. Llangefni for the repair and replacement of the safety surfacing - £12,495 plus VAT for replacing the rubber tiles with a wet pour surface which had a guarantee of 5 years and £1,439 plus VAT for repairing all gaps which they would guarantee for 6 months.
 - It was agreed to seek further quotes and discuss this again next month.
- 2. **Bus Shelters:** It was agreed to ask William Evans and Sons Ltd to replace the nuts and bolts required on the bus shelter opposite the church on Minffordd Road and to pay them the remainder of the payment due for making good the bus shelter.
 - There had been a number of representations made to Members regarding the condition of the bus shelter on the Minffordd Road / Dinam Road junction. It was resolved that the clerk should contact the Managing Agents again to explain that the Community Council could not make good the shelter as it stood on private ground and was not Council property.
- 3. Vacant Seats: it was resolved to fill the vacant seats by co-option.
- 4. Maintenance Treifan Estate it was agreed that the clerk would ask Dylan Roberts whether he could assist with repairing the wall.
