- 1. Playing Field It was noted that Mr Medwyn Owen had done his quarterly inspection the equipment generally was in good order but minor work was required on the swings, slide, paths and benches. The clerk was asked to look at this.
- 2. Highway Maintenance the clerk was awaiting a reply from IOACC regarding the maintenance of Cymyran Road.
- 3. Notice Board The Senior Valuation Officer could see no problem with erecting notice boards on IOACC ground but he would discuss this further with the Housing Department. In the meantime he would forward a map of the areas he considered most suitable. He had also confirmed that planning permission was required.
- 4. Parking Minffordd Road It was noted that parking on the pavement is not illegal outside of London, therefore IOACC had no power to deal with offenders. However motorists causing an unnecessary obstruction to other vehicles, prams, pedestrians etc. by parking on the pavement could receive a Fixed Penalty Notice if spotted by the police. Photographic evidence of offenders should be sent to North Wales Police.
- 5. Criteria for Caravan Parks it was noted that the Caravan Club Sites located locally were classed as Certificated Sites and as such did not require planning permission. They were able to accommodate up to 5 caravans or motorhomes, and
