2. Cofnodion

Cadarnhawyd cofnodion y cyfarfod rhithiol a gynhaliwyd ar 21 Gorffennaf 2021 fel rhai cywir. Yn codi:

Toiledau Cyhoeddus: Cafwyd trafodaeth ynghylch y trefniadau rheoli presennol, gan gydnabod bod angen adolygu'r sefyllfa a datblygu strategaeth ddiwygiedig ar gyfer y dyfodol.

3. Strategaeth Dai 2022-27

Cafwyd cyflwyniad gan y Swyddog Strategaeth Dai ar Strategaeth Dai drafft a fydd yn destun ymgynghoriad cyhoeddus rhwng 4 Hydref a 15 Tachwedd.

Amlinellir isod prif bwyntiau'r drafodaeth ddilynol:

- Croesawyd y strategaeth ddrafft, ac fe roddwyd canmoliaeth i'r hyn y mae swyddogion y gwasanaeth wedi'i gyflawni eisoes i wella'r ddarpariaeth dai ar yr yns
- Bydd y strategaeth ddrafft yn sail gadarn i leihau anfantais economaidd-gymdeithasol dros y tymor hir (Caergybi)
- Pwysigrwydd dysgu gwensi o'r gorffennol er mwyn gwarchod cymunedau'r dyfodol (Llanfaelog; Biwmares; Mechell)

Eglurwyd y bydd cyfle i'r cynghorau fanylu am unrhyw broblemau penodol fel rhan o'r ymgynghoriad ac annogwyd y cynghorau i gyflwyno sylwadau erbyn 15 Tachwedd.

Nodwyd y bydd yr ymgynghoriad hefyd yn cynnwys dolen at holiadur anghenion tai, er mwyn ceisio cael gwell dealltwriaeth o'r sefyllfa ar draws yr yns. Gofynnwyd am gymorth y cynghorau tref a chymuned i hyrwyddo'r holiadur o fewn eu cymunedau.

Gweithred: Y ddolen at y ddogfen ymgynghori i'w chylchredeg i'r holl gynghorau tref a chymuned.

4. Adolygiad o drefniadau etholiadol y Cyngor Sir: diweddariad gan Bennaeth y Gwasanaethau Democrataidd

Nodwyd fel a ganlyn:

- Llywodraeth Cymru newydd ddatgan eu bod yn derbyn cynigion terfynol y Comisiwn Ffiniau (14 ward a 35 aelod), gyda dim ond un newid o bosib (newid enw ward *Tref Cybi i Caergybi*) – disgwyliir cadarnhad terfynol o hyn a bydd y Gorchymyn Statudol yn cael ei gyhoeddi'n fuan.
- Etholiadau i'w cynnal ar 5 Mai 2022 a phobl ifanc dros 16 oed yn cael pleidleisio yn yr etholiadau lleol am y tro cyntaf – mae'r gofrestr etholiadol yn cael ei diweddar ar hyn o bryd ac mae'r Cyngor yn hyrwyddo pwysigrwydd cofrestru ar gyfryngau cymdeithasol / gwefan y Cyngor.
- Y Cyngor Sir, ynghyd â holl gynghorau Cymru, wedi mabwysiadu datganiad i geisio cynyddu amrywiaeth ymmsg ymgeiswyr sy'n sefyll etholiad i fod yn gynghorwyr - bydd angen rhannu gwybodaeth yn eang am rôl cynghorydd dros y misoedd nesaf, er mwyn denu unigolion o'r grwpiau a dangynrychiolir i sefyll etholiad.
- Bydd gwybodaeth ar gael ar wefan y Cyngor a sesiynau rhithiol ar gyfer darpar ymgeiswyr i'w trefnu yn y flwyddyn newydd

Gofynnwyd i'r Cyngor dynnu sylw hefyd at yr etholiadau cynghorau tref a chymuned a gynhelir ar yr un diwrnod (Biwmares). Eglurwyd y byddai hynny'n digwydd fel rhan o'r sesiynau ac y dylai'r cynghorau tref a chymuned ofyn hefyd am gefnogaeth gan Un Llais Cymru.

5. Cryfhau gorfodaeth yngylch defnyddio cychod dŵr hamdden a phersonol yn beryglus (eitem ar gais CC Llanfairpwll)

Cyfeiriwyd at ymgynghoriad sy'n cael ei gynnal gan Adran Drafnidiaeth Llywodraeth y DU ar yr uchod (gweler y ddolen isod).

Eglurodd y Dirprwy Brif Weithredwr fod gan y Cyngor Sir gyfrifoldeb cyfreithiol dros y dŵr o amgylch Ynys Môn, gan gynnwys y Fenai, ac yn bwriadu ymateb i'r ymgynghoriad, efo mewnbwn gan arbenigwyr cyfreithiol. Yn ychwanegol, roedd arolwg o'r defnydd a wneir o gychod dŵr hamdden ar ran o'r Fenai ar y gweill ac mae'r Cyngor hefyd yn aros am adroddiad i'r ddamwain angheul a ddigwyddodd ym mis Awst 2020.

Gofynnwyd i'r Cyngor Sir gyfeirio at yr angen i gymryd camau i ddiogelu bywyd gwylt yn ei ymateb, gan nodi nad oedd unrhyw gyfeiriad at fywyd gwylt yn y ddeddfwriaeth gyfredol (Trearddur).

Anogwyd y Cynghorau Tref a Chymuned perthnasol i ymateb i'r ymgynghoriad sy'n cau ar 1 Tachwedd 2021 a gwahoddwyd cynghorau i gysylltu â'r Cyngor Sir os yn dymuno unrhyw wybodaeth ychwanegol neu gymorth i ymateb.

2. Minutes

The minutes of the virtual meeting held on 21 July 2021 were confirmed as a correct record. Matters arising:

Public Conveniences: A discussion took place on the current management arrangements, recognising the need to review the situation and develop a revised strategy for the future.

3. Housing Strategy 2022-27

A presentation was given by the Housing Strategy Officer on a draft Housing Strategy that will be subject to public consultation between 4 October and 15 November.

The main points from the following discussion are outlined below:

- The draft strategy was welcomed and officers of the service were praised for their achievements to date in improving housing provision on the island
- The draft strategy will provide a sound basis for reducing socio-economic disadvantage in the long term (Holyhead)
- The importance of learning lessons from the past in order to protect the communities of the future (Llanfaelog; Beaumaris; Mechell)

It was explained that councils will have an opportunity to provide details of any specific problems as part of the consultation and councils were encouraged to submit observations by 15 November.

It was noted that the consultation would also include a link to a questionnaire on housing needs, in an attempt to obtain a better understanding of the situation across the island. The assistance of the town and community councils was sought to promote the questionnaire within their communities.

Action: The link to the consultation document to be circulated to all town and community councils.

4. Review of the Council's electoral arrangements: update from the Head of Democratic Services

It was noted as follows:

- Recent announcement by the Welsh Government that the Boundary Commission's final proposals have been accepted (14 wards and 35 members), with only one possible change (one ward name change - *Tref Cybi* to *Caergybi*) – final confirmation of this is awaited and the Statutory Order is expected to be published shortly.
- Elections to be held on 5 May 2022 and young people over 16 years old will be able to vote in the local elections for the first time – the electoral register is currently being updated and the Council is promoting the importance of registering on social media / the Council's website.
- The County Council, along with all councils in Wales, has adopted a declaration to increase diversity amongst candidates standing to be elected councillors – information about the role of councillors will need to be shared widely over the coming months to attract individuals from under-represented groups to stand for election.
- Information will be available on the Council's website and virtual sessions for prospective candidates will be arranged in the new year.

The Council was asked to also draw attention to the town and community council elections that will be held on the same day (Beaumaris). It was explained that this would be happening as part of the sessions and that town and community councils should also ask for support from One Voice Wales.

5. Strengthening enforcement of the dangerous use of recreational and personal watercraft (item requested by Llanfairpwll CC)

Reference was made to the current consultation by the UK Government's Department for Transport on the above (see link below).

The Deputy Chief Executive explained that the Council had a legal responsibility for the waters around the island, including the Menai Strait, and intended to respond to the consultation, with input from legal specialists. In addition, a review of the use of recreational watercraft on a section of the Menai Strait is currently being undertaken and the Council was also awaiting a report on the fatal accident that happened in August 2020.

The County Council was requested to refer to the need to take steps to safeguard wildlife in its response, noting that there was no reference whatsoever to wildlife in the current legislation (Trearddur).

Relevant Town and Community Councils were encouraged to respond to the consultation that closes on 1 November 2021 and invited councils to contact the County Council if they required any further information or assistance to prepare a response.

6. Any Other Business: Planning Applications

Reference was made to two issues of concern related to dealing with planning applications discussed at a recent meeting of the local branch of One Voice Wales:

Planning Portal – a number of technical problems when using the system, regarding timing and availability of information, tracking correspondence etc.

Action: The Planning Service to hold direct discussions with all town and community councils, to get the full picture of the technical problems and to respond appropriately.

Submitting comments on planning applications – specialist training

Action: Planning Services officers to deliver a presentation to the Forum after the 2022 local elections.

The meeting ended at 7.50 pm.
