#### **Introduction and Context**

The Community Council area of Llanfair yn Neubwll includes the villages of Caergeiliog, Llanfihangel yn Nhowyn and Llanfair yn Neubwll. The area has a population of **1,733** (2021 census) and is represented by 11 Community Councillors. The Council has a precept of £21,000 for 2025-26.

The hamlet of Llanfair yn Neubwll is situated on the strait opposite Holy Island on the west coast of Anglesey and is a rural community with isolated clusters of settlements, the village of Caergeiliog is situated on the A5 between junction 3 and 4 of the A55 North Wales Expressway and the third village Llanfihangel yn Nhowyn is home to the Royal Air Force Station known as RAF Valley.

The base was established on Tywyn Trewan during the Second World War when large areas of the coastal sand dunes were levelled to create runways. Silt was dredged from the nearby marches and lakes to spread over the airfields to stabilise the sand from the dunes. Prior to this Llyn Penrhyn and Llyn Dinam were the only major lakes in the area but a cluster of smaller lakes were created during the process. The remaining area of Common Land is now managed by the Tywyn Trewan Board of Conservators.

Llyn Penrhyn, Llyn Treflesg, Llyn Traffwll and parts of Llyn Dinam and form 'Valley Wetlands' which is a Nature Reserve owned by the Royal Society for the protection of Birds. Much of the reserve is included within two Sites of Special Scientific Interest and the Community Council is responsible for maintaining a network of public footpaths that link and allow access to the Wetlands.

The Community Council became responsible for Caergeiliog Village Hall and grounds in July 2024, prior to this the scope for promoting biodiversity was somewhat limited in that the only other area of direct management apart from the public footpaths was the Treifan Playing Field. The hall grounds provide an exciting opportunity to work with local residents to develop and promote biodiversity.
